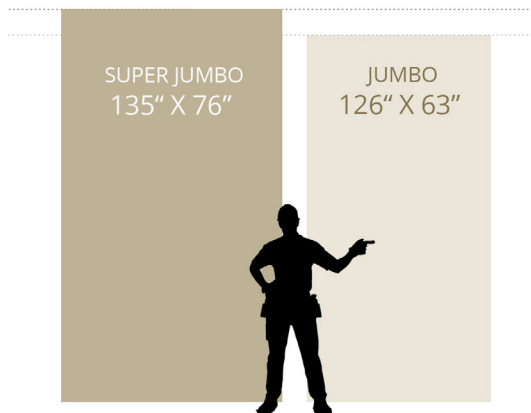

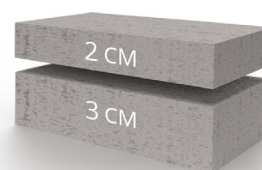

However, it does not cover the costs associated with manufacturing and installing the product. Faults arising from the preparation or installation of the product are not covered by the warranty, as Copa does not perform these activities.

For this form to be considered valid:

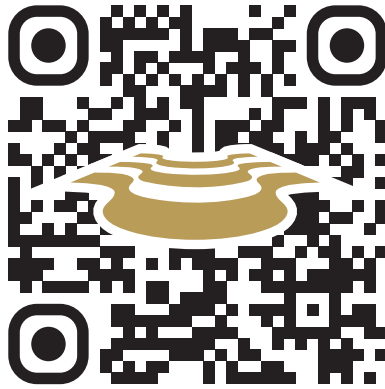
- All fields must be clearly filled, providing accurate information.

Your data will be stored for 25 years after the end of the commercial relationship to comply with the company's legal obligations.
