



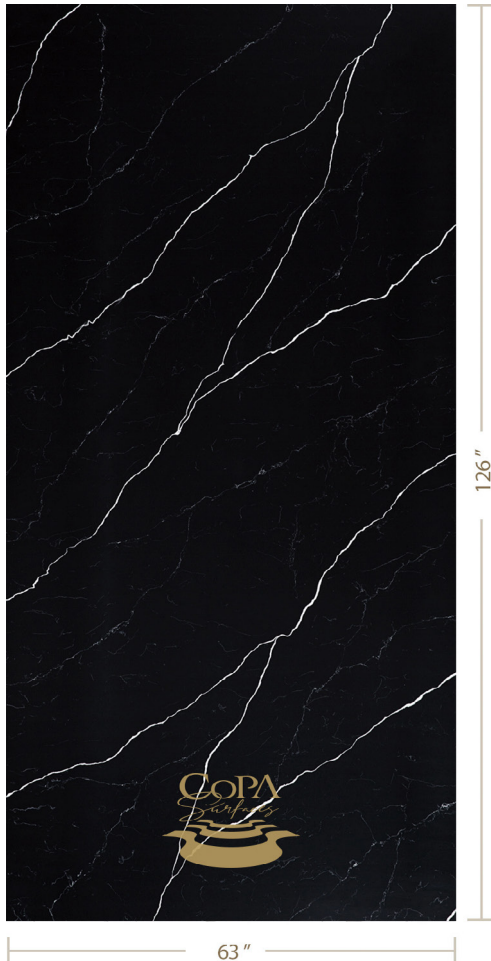

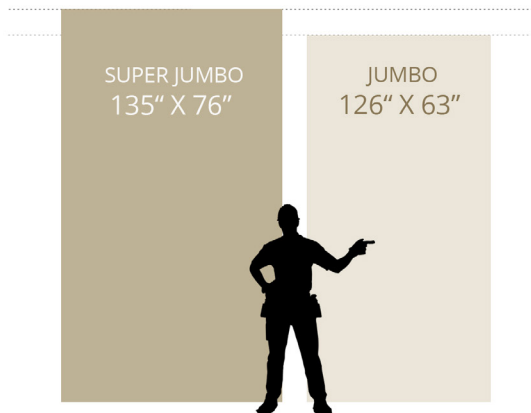

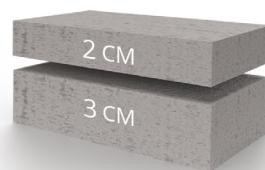

MATERIAL THICKNESS COMPARISON



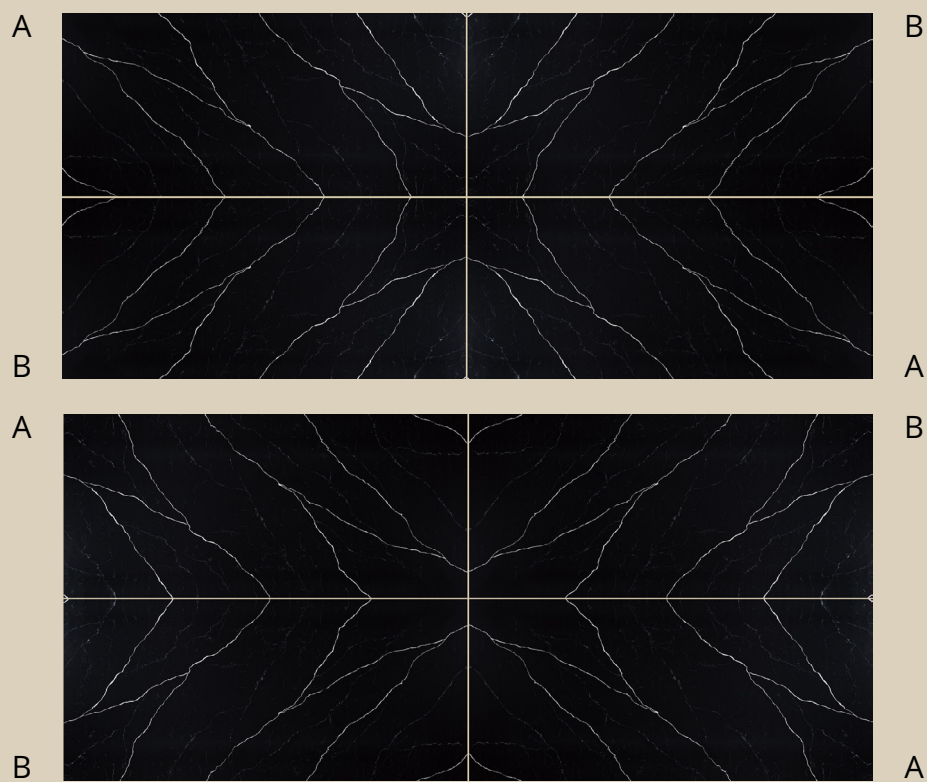
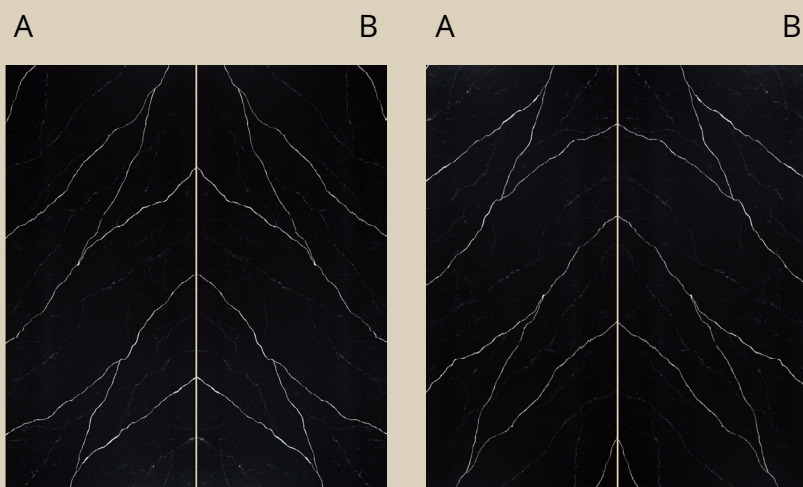
